

Revised Annual Population Estimates for Florida and Its Counties, 2000–2010, with Components of Growth

Population counts from the 2010 Census show that Florida's population grew by more than 2.8 million during the past decade, an increase of 17.6% since 2000. The numeric increase was the third largest among the 50 states and the percent increase was the eighth largest. Sixty-five of the state's 67 counties gained population during the decade, with four growing by more than 50% and another twenty growing by at least 20%.

The Bureau of Economic and Business Research (BEBR) has made population estimates for every city and county in Florida each year since 1972. These estimates are based on previous census counts and symptomatic indicators of population change such as active residential electric customers, building permits, and homestead exemptions. The estimates are used for a variety of budgeting and planning purposes in both the public and private sectors, including the distribution of billions of dollars in state revenue-sharing funds each year.

Despite complications created by changes in the mix of seasonal and permanent residents, a housing boom and bust, and a severe economic recession, the 2010 population estimates prepared by BEBR were very accurate. The state estimate was less than 0.2% lower than the census count. For counties, the estimates had an average error of 0.5% when the direction of error was accounted for and 2.7% when it was not. Errors were less than 2% in 29 counties, between 2% and 5% in 30 counties, and greater than 5% in only eight

counties. The estimates were higher than census counts in 33 counties and lower in 34 counties.

For most counties, then, the population estimates published by BEBR during the decade provided reasonably accurate indications of population change. Nevertheless, there are several reasons for producing a revised series of annual estimates. First, a revised series can correct for errors in the data used to construct the original estimates. Second, a revised series can draw on data that were not available when the original estimates were produced. Finally, and perhaps most important, a revised series can incorporate the results of the 2010 Census, providing annual estimates that are consistent with both the 2000 and 2010 counts.

For the state and most counties, the revised estimates published in this report did not differ substantially from the estimates originally published by BEBR. Years with rapid growth in the original estimates generally had rapid growth in the revised estimates, and years with slow growth in the original estimates generally had slow growth in the revised estimates. There was one notable change, however. Whereas the original estimates showed a small decline in Florida's population between 2008 and 2009, the revised estimates show a small increase. This revision was made because recent data suggest that the estimates made in the middle of the decade were somewhat high. We believe the revised estimates provide a more accurate picture of annual population changes during the decade than the estimates published originally.

Analysis of Trends

Table 1 shows revised population estimates for the state and each county for April 1 of each year between 2000 and 2010.¹ These estimates refer solely to permanent residents, thereby excluding seasonal and other non-permanent residents. They include persons living in prisons, nursing homes, college dormitories, and other group quarters facilities as well as persons living in households.

Table 2 shows changes in the permanent resident population for each year. For the state as a whole, annual increases rose steadily from 2000 until 2005. Several of these increases were among the largest in Florida's history. Annual increases then started falling, reaching the lowest levels in 60 years by the end of the decade. This dramatic slowdown was caused by the worst economic recession since the 1930s, which reduced the number of people moving into the state and raised the number moving out.

For the decade as a whole, all but two Florida counties (Monroe and Pinellas) experienced population growth. Many counties, however, had annual population declines at least once during the decade. Some counties (e.g., Hardee and Union) had population losses because of fluctuations in the group quarters population. Others (e.g., Charlotte and Escambia) had losses due to heavy hurricane damage in 2004. Twenty-four counties lost population in one or both of the last two years of the decade due to a declining housing market, substantial job losses, and a generally deteriorating economic climate.

Tables 3–6 show the components of change for each year. Calendar-year data on births and deaths were provided by the Florida Office of Vital Statistics; we transformed those data into April-to-April numbers by assuming that one-quarter of the births and deaths each year occurred in January, February, and March.² Natural increase was calculated as the difference between the numbers of births and deaths for each year. Net migration was calculated as the difference between total population

change and natural increase; it reflects the difference between the number of people moving into an area each year and the number moving out.

For the state as a whole, the number of births rose during the first seven years of the decade but declined during the last three years. Deaths followed a generally upward trend throughout the decade, but year-to-year changes were fairly small. As a result of these trends, natural increase rose from around 40,000 early in the decade to nearly 69,000 in 2007–2008, before falling to just over 51,000 in 2009–2010.

Most counties followed similar birth and death trends over the course of the decade, but levels of natural increase differed dramatically from county to county, primarily because of differences in age structure and racial/ethnic composition. In the last year of the decade, natural increase ranged from -2,555 in Pinellas County to 14,545 in Miami-Dade County. Twenty-two counties had more deaths than births in the last year of the decade, compared to 26 counties in the first year.

At the state level, net migration rose from less than 282,000 in 2000–2001 to just over 352,000 in 2004–2005 but then began falling. Declines accelerated with the onset of the recession in late 2007, with net migration dropping to less than 15,000 in 2008–2009 before rising to almost 63,000 in 2009–2010. Clearly, net migration rather than natural increase was the major cause of shifting population growth rates over the course of the decade.

The vast majority of counties had net in-migration during the first six or seven years of the decade; that is, more people were moving in than moving out. The numbers were often quite large, exceeding 10,000 per year in many counties. The numbers began falling in the latter part of the decade and no county had net in-migration greater than 10,000 in any of the last three years. In fact, by the end of the decade, many counties had more people moving out than moving in. Whereas only seven counties had net out-migration in 2006–2007, 11 counties had more out-migrants than in-migrants in 2007–2008, 21 counties in 2008–2009, and 24 counties in 2009–2010. As noted previously, these shifts in migration trends were caused by a declining housing market, substantial job losses, and a generally deteriorating economy.

¹ The 2000 Census numbers shown in this report may differ from those published previously because they include corrections made by the U.S. Census Bureau.

² For 2010, we used data for the first three months of the year rather than using one-quarter of the annual data.

Methodology

The revised series of annual estimates of total population were based on three independent sets of annual county estimates: estimates produced by the U.S. Census Bureau, estimates based on changes in active residential electric customers, and estimates based on changes in homestead exemptions. In all three sets, we adjusted the estimates to be consistent with 2010 Census counts and with annual changes in institutional populations (i.e., persons living in prisons or state hospitals). The revised estimates were made as follows:

The U.S. Census Bureau produces annual population estimates for all counties in the United States using data on births, deaths, and migration. We adjusted these estimates by subtracting the institutional population from the counts of total population in 2000 and 2010, providing counts of the non-institutional population; calculating ratios of the non-institutional census counts to the non-institutional population estimates in 2010; constructing linear interpolations between these ratios and 1.0 in ten equal parts, providing ratios for each year between 2000 and 2010; multiplying these ratios by the original Census Bureau non-institutional estimates for each year (adjusted to April 1); and adding back the institutional populations. This process yielded an adjusted set of annual population estimates that were based on the original Census Bureau estimates but were consistent with 2010 Census counts.

Using data from the 54 electric power companies in Florida, we calculated ratios of the non-institutional population to the number of active residential electric customers in 2000 and 2010 for each county. We linearly interpolated these ratios to each year between 2000 and 2010 and multiplied the resulting ratios by the number of active residential electric customers in each year, yielding annual estimates of the non-institutional population for each county. We then added institutional populations, providing a second set of annual population estimates for each county.

We followed an identical procedure using homestead exemptions instead of active residential electric customers, providing a third set of annual population estimates for each county.

Finally, we calculated two averages based on these three sets of estimates. The first was an average of the adjusted Census Bureau estimates and the electric customer estimates and the second was an average of all three sets of estimates. We evaluated each average and each individual set of estimates for each county and chose the one that we believe provided the most reasonable series of annual estimates. We chose the first average in 37 counties, the second average in 12 counties, and the adjusted Census Bureau estimates in 18 counties. In all 67 counties, we smoothed the annual changes by calculating a weighted average in which the population estimates for a given year were given a weight of 80% and the estimates for the immediately preceding and following years were given weights of 10% each.

Conclusion

The revised county population estimates published here are consistent with each other and with the 2000 and 2010 Census counts. We believe they provide a more realistic picture of annual population changes than the estimates published originally. The revised estimates are still subject to error, of course, due to errors in the underlying data and the census counts themselves. In spite of these shortcomings, we believe the revised estimates provide accurate and useful information regarding annual changes in total population and the components of growth for Florida and its counties between 2000 and 2010.
